



## Rotherham u3a Policy for Environmental Issues V1.0

### Aims of this policy

Given the widespread concern amongst u3a members and wider society about climate change, National u3a suggests that u3as consider adopting these guidelines and encourage groups within the u3a to reflect on the way their activities may impact on climate change, biodiversity loss and the environment.

### Rationale

This policy has been drawn up to provide suggestions on how Rotherham u3a might introduce environmental guidelines within their activities in order to make a positive contribution to sustainability and the environment, and also to help mitigate climate change. More specifically, the measures listed below can help Rotherham u3a to:

- address the concerns of members and wider society with regard to environmental issues
- encourage communication and dialogue on environmental issues within Rotherham u3a
- encourage a culture of awareness and a sense of responsibility within the membership with respect to sustainability and environmental issues
- provide information to members on how they might reduce their adverse impact on the environment
- minimise the environmental impact of organised Rotherham u3a activities

### Practical Measures

The following are suggestions to raise awareness and to minimise environmental impact. Please note that committee members and group leaders have an important part to play in supporting these measures during the activities of Rotherham u3a.

- Rotherham u3a will appoint one member as an Environmental Officer to monitor environmental issues arising within the u3a.
- Arrange speakers on environmental topics for some monthly meetings.
- Wherever possible incorporate environmental concerns into planning and decision making.



- Consider the impact of activities which take place outside, in natural ecosystems e.g. walking and nature groups and how trips and holidays could be made more sustainable.
- Encourage the formation of climate and environmental groups within the u3a.
- Check whether venues operate environmentally responsible policies such as using local suppliers, and encourage them to do so.
- Ensure as far as possible that refreshments are served in an environmentally friendly manner e.g. using crockery rather than disposable cups and plates.
- Minimise waste and encourage reuse and recycling.
- Encourage travel to meetings and events by walking, car sharing and public transport where available.
- To use digital documents where possible and avoid printouts unless absolutely necessary.
- Conduct a survey of members to seek their views on climate and the environment and suggestions for measures which might be taken by the u3a.
- Encourage members to register for a digital newsletter wherever possible and to share their used copies of the newsletter out to the community.
- Make this policy available on the website and draw your members attention to it.
- Encourage dialogue on climate change issues with the wider population including e.g. younger people.

## Definitions

**Environmental issues:** These are the often-negative effects of human activity on the natural world, including climate change, pollution, drought and biodiversity loss.

**Environmental protection** is the practice of working to slow, halt or reverse this.

**Climate Change:** The United Nations defines climate change as referring to long-term shifts in temperatures and weather patterns. These shifts may be natural, but since the 1800s, this is primarily due to humans burning fossil fuels. A **Climate Emergency declaration:** (or *declaring a climate emergency*) is an action taken by governments and scientists to acknowledge humanity is in a climate emergency.
